Re: Modified Directives for conducting KMAT Kerala 2016 Programme

ORDER ISSUED ON 19.01.2016

In continuation and in partial modification of the directives issued by the ASC on 11.05.2015 and 24.11.2015, all the representatives of the universities in the meeting dated 14.01.2016 considered the complaints of applicants about the shortage of time for preparation to the KMAT Kerala 2016 Entrance Examination (the **Kerala Management Admission Test**). The intervening other important tests were also brought to the notice of the committee.

The University representatives, therefore, met and proposed, after the required deliberations, about the

postponement of the KMAT Kerala 2016 Entrance Examination. Accordingly, the Entrance examination is rescheduled from **31.01.2016 to 03.04.2016.**

The last date for submission of online application to KMAT Kerala 2016 shall be 20.03.2016.

This postponement of date from 31.01.2016 to 03.04.2016 is applicable only to 2016 MBA admissions on considering the complaints filed before the Committee.

From 2017 admissions, the KMAT Kerala Entrance Examination shall only be held on the last Sunday of January i.e., 29.01.2017 and the starting of the classes shall be on the 1st of June 2017.

While the cut off marks is maintained at 10% [72 out of 720] for SC/ST and SEBC applicants the cut off marks will be 7.5% [54 out of 720].

Apart from the 14 Districts there will be another examination centre in Lakshadweep.

All the universities in Kerala shall take the necessary steps to implement the directives issued by the ASC on 11.05.2015 and 24.11.2015 together with these directives, by bringing about the necessary changes in the University Regulations/ Procedures.

Email these directives to all the Universities in Kerala, all the MBA Self Financing Colleges and publish it in the website of the ASC.
